## Introduction



### Fund Overview

The Milford Dynamic Small Companies Fund is a dedicated small to mid-cap equity fund, modelled on an existing Milford strategy which has been running since 2013. The Fund is actively managed and invests primarily in small to mid-cap Australian equities. The Fund is managed by our experienced Sydney-based investment team, and leverages the skills of 30 investment professionals in Sydney and Auckland.

### Investment Objective

The Fund targets outperformance of the S&P/ASX Small Ordinaries (TR) Index over the minimum recommended investment timeframe (net of fees).

### Investment Strategy

The Fund invests primarily in small to mid-cap listed or soon to be listed Australian equities. Derivatives may be used for efficient portfolio management and for foreign currency hedging.
