The Milford Global Growth Fund (AU) is a global equity fund, modelled on an existing Milford strategy which has been running since 2016. The fund aims to provide capital growth by investing in global equity securities with strong growth characteristics. Investment Objective

The Fund targets capital growth by outperforming the MSCI World Index, over the minimum recommended investment time horizon (net of fees).

The Fund will look to manage risk through appropriate portfolio diversification and utilise derivatives for efficient portfolio management and foreign currency hedging.
