The Fund return was flat in September as equity markets marched higher amidst ongoing enthusiasm for the generative AI theme and a resumption of interest rate cuts in the US.

Positive contributors: Increased optimism around the level and duration of investment in Artificial Intelligence infrastructure drove semiconductor holdings higher, including leading foundry TSMC (+21.3%) and semiconductor equipment companies KLA (+23.7%) and ASML (+30.1%).

The enthusiasm also buoyed shares of industrial company Legrand (+8.1%), which is well-placed to benefit from datacentre investment. Building materials group CRH (+6.2%) gained after management provided long-term financial projections that were above the market's expectations.

Detractors: Technology company Roper (-5.2%) declined alongside several software industry peers as investors continue to prefer semiconductor exposure. Two of the Fund's larger positions, food services provider Aramark (-1.8%) and industrial services provider APi Group (-3.7%) were subdued on little news flow and we retain conviction in the multi-year investment proposition these shares present. Meanwhile, not owning car company Tesla (+33.2%) impacted performance relative to the market index.


Fund Activity: A new position was initiated in software provider Monday.com, where attractive growth potential appears undervalued after investors, in our view, overreacted to very modest headwinds to growth from Google search engine optimisation. Industrial company Legrand was added on pullback to increase the Fund's exposure to datacentre investment.

US cruise liner Carnival Corporation is benefiting from attractive demand for cruise vacations, with robust bookings extending well into 2026. We exited US brokers Interactive Brokers on valuation and are monitoring the stock for opportunity to reinvest in what we consider a high-quality business with strong growth prospects.

We continue to maintain a portfolio of attractively valued good quality companies with idiosyncratic drivers of investment returns.


